RE: Durham/York Energy from Waste Project

Submission of the Groundwater Well Development

MOE File No.: EA-08-02

The Regional Municipality of Durham and The Regional Municipality of York (Regions) have commenced the groundwater and surface water monitoring in accordance with the Plan which was approved by the Ministry of the Environment (MOE) on October 14, 2011.

In preparation for the monitoring, the Regions installed and developed four of the five required groundwater wells in late December 2011. The fifth monitoring well, located in the centre of the property, as noted in the plan, cannot be installed until after the construction is complete due to conflict with site construction. The first groundwater sampling in accordance with the Plan was undertaken in March 2012 and marks the commencement of the monitoring program. Wells are sampled in accordance with the Plan every spring, summer and fall, and will continue throughout construction and into the operating phase.

The surface water portion of the Plan will be delivered in two phases: on-site monitoring during construction and off-site monitoring commencing after first receipt of waste. On site monitoring commenced in March 2012, with weekly erosion and sediment reports being generated during construction phase in accordance with the Plan by a qualified Environmental Monitor and Inspector.

In accordance with EA Condition 20.8 which states:

"The proponent shall prepare and submit to the Director and Regional Director, an annual report containing the results of the groundwater and surface water monitoring program. The first report shall be submitted 12 months from the start of the monitoring program and every year thereafter."

the Regions propose to submit the annual report, including results for both ground and surface water, no later than April 30th of each year. This timeframe will allow for one full year of both groundwater and surface water data respective to the start date of monitoring to be analyzed by a Competent Environmental Practitioner and included in the annual report.

We trust that this well development information and the proposed ground and surface water reporting timelines meet the MOE's expectation. We have included the well borehole logs and the well development sample results as an attachment to this letter.
